PROCUREMENT DECISION OF THE FINNISH TRANSPORT AND COMMUNICATIONS AGENCY TRAFICOM

Tendering process for air services to five regional airports

TENDERING PROCEDURE

1. Object of the procurement and agreement period

The object of the procurement is the operation of scheduled air services from Kemi, Kokkola, Kajaani, Jyväskylä and Joensuu to Helsinki Airport in accordance with the public service obligation.

The contract period of the public service obligation for scheduled air services is from 31 October 2022 to 30 July 2023.

2. Estimated total value of the procurement

According to the buyer's estimate, the value of the procurement with services to all destinations combined is EUR 14 million. This covers the base agreement period without optional flights. With optional flights, the total appropriation reserved for the procurement is EUR 17 million. The sum only covers procurement in the base agreement period. If the procurement option is utilised, an appropriation must be allocated for it. The longest possible option period is from 31 July 2023 to 28 April 2024.

3. Tender procedure and invitation to tender

The tender procedure used was in accordance with the Regulation (EC) No 1008/2008 of the European Parliament and of the Council on common rules for the operation of air services in the Community (hereinafter 'the Air Services Regulation'). According to section 9, subsection 1, paragraph 15 of the Act on Public Procurement and Concession Contracts (1397/2016), the Act on Public Procurement and Concession Contracts shall not apply to the procedure. The announcement concerning the tendering procedure was published on 27 June 2022 in the Official Journal of the European Union 2022/C 241/09.

In accordance with the invitation to tender, the deadline for submitting tenders was 29 August 2022 at 13:00 Finnish time (LT EE).

The tender opening events were held on 29 August 2022, 30 August 2022 and 31 August 2022.

4. Documents examined in the tender procedure

Eight (8) tenders were received by the deadline:

- 5. Assessment of the suitability of the tenderers and the compliance of the tenders with the invitation to tender

The conditions for the suitability of the tenderers were specified in section three of the invitation to tender. Along with the tender, tenderers were required to submit the forms 3, 4, 5 and 6 appended to the invitation to tender (net cost calculation, background information table, tender form and tender selection criteria). In addition to these, the tenderers had to attach a valid operating licence granted by a competent licensing authority of an EU member state according to Article 3 of the Air Services Regulation, and an air operator certificate in accordance with Article 6. They also had to present a description of the aircraft used in the operations, an account of at least two years of experience in scheduled air services for passengers in the EU during 2016–2022; the Articles of Association and financial statements for the past three financial years, a statement from the tax authorities on outstanding taxes of the tenderer, and a statement from the relevant insurance company indicating that employee accident insurance premiums and pension contributions for the tenderer are fully paid up.

Moreover, they had to present a report about the interline agreement (section 3.7 of the invitation to tender). A commitment to the schedules presented as well as the ticket pricing was required in the tender.

In connection with the suitability assessment, supplements to the documentation were requested.

Amapola Flyg AB (hereinafter 'Amapola') was asked to provide a more recent statement on outstanding taxes as well as an insurance certificate, which were received and found appropriate.

DAT A/S was asked to supplement their tender by providing the *attestato cumulativo* in Finnish, English or Swedish, the air operator certificate of the tenderer translated into English, part OM-A of the Operations Manual, tender pages 164–169 in English, Swedish or Finnish as far as the tenderer is concerned,

and the identification of the aircraft to be used.

Finnair Oyj was asked to supplement the documents proving suitability; a report of the interline agreement and the available back-up aircraft.

NyxAir OÜ was asked to supplement the documents proving suitability; an extract of the Operations Manual OM-A, financial statements for 2021, articles of association and proof of insurance payments.

The assessment concluded that the tenders included all the information required by the invitation to tender, that the tenders did not contain any terms or conditions contrary to the invitation to tender and that the tenders were compliant with the invitation to tender in other respects as well.

6. Tender comparison method and a summary of the comparison

For destinations 1, 2 and 3, the selection criterion for the tendering process was the tender price of a rotation (a round-trip flight). For destination 4, the selection criterion was the price for the entire contract period. The comparison criteria are described in section 4 of the invitation to tender.
